

Beaufort County Parks & Recreation

Camp Scholarship Application

The camp scholarship program provides partial scholarships to children eligible for our summer camp programs who live in households making less than the Federal Poverty Level as defined by the Department of Health and Human Services. Households making less than 130% of the Federal Poverty Level are still encouraged to apply to gauge community need for future scholarship programs.

NOTE: This financial assistance program is intended to be a resource after other sources of funding have been utilized. Completion of this application does not guarantee a spot in the camp, nor an approved scholarship. To reserve a spot in the camp, a 50% non-refundable deposit is required. This deposit will not be refunded if the scholarship request is denied and the remaining 50% is due no less than 3 weeks prior to the start of the requested camp session. The maximum scholarship value is 50% of the cost of the camp. Only Beaufort County residents are eligible.
